- The Government of Nepal [GoN] and Baudikali Rural Municipality has allocated funds or received a loan/credit/grant from GoN towards the cost of Construction of Administrative Building of Baudikali Rural Municipality and intends to apply part of the funds to cover eligible payments under the Contract for BAUD/NCB/Works-2/2078/79. Bidding is open to all eligible as per Section V of bidding document.
- Baudikali Rural Municipality invites sealed bids or electronic bids from eligible bidders for the Construction of Administrative Building of Baudikali Rural Municipality (A RCC frame Structure) under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs.5,75,50,000
- Minimum Work experience of similar size and nature: At least one RCC frame Structure constructed within the last ten (10) years each with a value at least NRs.6,14,00,000
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 25th Feb 2022 (2078/11/13) at the office of Baudikali Rural Municipality, Dedhgaun, Nawalparasi (Ba.Su.Pu). Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, \amounting to a minimum of NRs 20,00,000 which shall be valid for 30 days beyond the validity period of the bid
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. All other terms and conditions will be as per Nepal Governments Prevailing Procurement Act and Regulations.
